# MINUTES OF PARTINGTON PARISH COUNCIL MEETING HELD REMOTELY ON MONDAY 7th SEPTEMBER 2020 AT 6.30 PM

The Chairman Cllr W Edwards (WE) opened the meeting at 6.30pm. He welcomed the Parish Councillors.

## 1. APOLOGIES FOR ABSENCE:

IT WAS RESOLVED by all Councillors that apologises received, were reviewed and accepted.

#### 2. OPEN FORUM:

The Chairman Cllr W Edwards (WE) explained that there were no members of the public in attendance due to the Coronavirus pandemic, but asked the Cllrs if they had received any questions from parishioners?

No questions had been received therefore the open forum was closed.

## 3. DECLARATIONS OF INTEREST:

## 4. MINUTES FROM THE PARISH MEETING HELD ON 6th JULY 2020:

IT WAS RESOLVED that the minutes [P1070 & 1072] were a true & accurate record and were passed by Cllr A Rudden & Cllr K Stewart.

There were no matters arising from this set of minutes.

## 5. CHAIRMANS REPORT:

The Chair (WE) thanked the Councillors for attending the remote meeting.

## 5.1 Broadway & Heath Farm Lane

The Chair has spoken to the developers and has requested that they prune the trees along the above roadside. It was said that the completion date of phase 1 will be approximately 2023, the gates that are located on Broadway originate to the 1940s.

# 5.2 Greyhound development

The Chair informed the meeting that he has spoken to M Davey regarding the light system due to the development works. The complaint is that they are not consistent with the works that are being carried out.

The issues will be mentioned to the developers and it will be requested that they observe the lights as it is important that they flow properly as over the last few weeks we have has 3 sets of traffic lights within one mile.

## 5.3 Oak Road Building

Updated the Cllrs that interest has been shown in regards to the purchasing of the Oak Road building. It was discussed and resolved that the Clerk will write to the proprietor of Little Oaks to enquire if they would be interested in purchasing the lease, as has been, previously offered and a quarterly bill will be sent for the forthcoming rent. The Chair asked the Council what would be the lowest figure that can be asked for the property. It was RESOLVED that the Chair ca deal with the interested party.

Actions: The Clerk is to organise another valuation and re check the lease and as we go along a solicitor will also be appointed.

Works to trees within TPO 363 specifically the removal of one early mature Sycamore Tree (T1(G93)) and replace it with two standard Oak Trees.

(Observations recorded online on 090920. At the recent Parish Council meeting it was asked 'is it the owner of 69 Thirlmere Road' that has asked for the application. If not, then who is the landowner that has applied for the application).

# 6.4 101133/FUL/20 - Oak Road Play Area, Oak Road, Partington, M31 4LD

Erection of additional netting above the current basketball structure with supporting posts to hold the netting in place.

# 6.5 101536/TPO/20 - 91 Thirlmere Road, Partington, M31 4PS

Works to trees within TPO 363 specifically the Crown lift to 6m and crown reduction of mixed species (Hawthorn & Ash) G1 (G127) and 1 mature Ash T2 (T128) trees.

(Observations recorded online on 090920. At the recent Parish Council meeting it was asked 'is it the owner of 91Thirlmere Road' that has asked for the application. If not, then who is the landowner that has applied for the application. Can you also confirm that it is not detrimental to the Ash trees to be crowned/pruned)?

Outline application for erection of 1 no. single storey detached bungalow with all matters reserved. (*Plans sent for perusal to the Parish Councillors*).

# 7.1 Davies Road garage issues reported to THT.

Cllrs had a meeting on site with THT officers. They discussed how this issue can be resolved. It was stated that THT will remove the fly tipped rubbish and will continue to update the PC of any changes to the site. The Clerk updated that she had reported to THT an excessive amount of fly tipping on the site that occurred on 030920. The Clerk was informed on 080920 at 10.43am that this has been sent to the 'Caretaking Service' to be dealt with as soon as possible.

The Clerk reported that there has been no further fly tipping in the area.

## 7.4 Moss Lane Building update.

Emails from PPC to Trafford Assets have been exchanged and a historically write up on the building was circulated to the Cllrs from Cllr JC. It was resolved that a meeting with TBC needs to take place and a walk around the building before any firm decisions can be made. This can be discussed at a further meeting. Cllr JRF said we could also ask for local trade people to help if the transfer is successful.
