The Clerk updated the Councillors on the recent meeting that she has had with the CIWs and YHG regarding the fly tipping around the estate. It was discussed what the procedure is as the fly tipping has to be dealt with in a certain way. It was therefore agreed and the Clerk will update YHG every Friday with reported issues.

The Council were brought up to date with the ongoing works at the Pavilion with Manchester Young Lives and PC Spinks from GMP.

### **14. ANY OTHER BUSINESS**

**WE** – Updated the Council on the future projects he would like to happen at the Pavilion; i.e Living accommodation for a facilities manager, petting animal corner, continued use of the football pitch an council yard. The Chair asked the Cllrs for their thoughts and ideas. He also updated them that we are still awaiting details on the Oak Road building and we will continue to update at the next meeting.

**AN** – Adele updated the meeting about a disturbance with a Partington gang and a gang from Stretford. There have been two arrests made and the police are aware of the ongoing issues. Adele also reported to the Clerk that there has been a large industrial fridge freezer dumped outside Oak Road shops; the Clerk will report this to Trafford.

**KW** - Asked if there was any update on the heating for the Pavilion as the bowlers may pull out of using the Pavilion. The Chair reiterated that we are dealing with it but as it was the bowlers that contacted us to use the facility, they were well aware that there was no heating or immediate funds to resolve this issue. Cllr Watson also mentioned that he has planters that can be used at POSH and that he has given the clerk details of a company that can install fake grass.

**AR** – Updated the Cllrs that the Parish Council hold a surgery at the Parish Council office on the last Wednesday of every month with YHG.
