MINUTES OF ANNUAL PUBLIC PARISH COUNCIL MEETING

HELD ON THURSDAY 17TH MAY 2018 AT 6.30PM AT THE COMMUNITY CENTRE PARTINGTON

The Chairman, Councillor Wayne Edwards, chaired the meeting and other Parish councillors in attendance were:

Everyone that attended the meeting was given a copy of the Agenda, Minutes of the previous Annual Public Meeting and a copy of the Parish Council Annual Report and Financial Statement.

1. WELCOME AND INTRODUCTIONS

However may I remind those in the room that once the Open forum has ended there will be no more questions taken, as this is a Council meeting? The meeting is conducted in a discussion format and the public will be allowed to stay and observe, unless there is something on the agenda that has sensitive nature, the public will then be asked to leave.

The Chair then continued with his remarks:

As Chair for the last year, I have formed stronger links with various agencies such as Your Housing Group and Trafford Borough Council and our local schools, allowing our youth and potential residents to understand what we the Parish Council do. I have helped to introduce and implemented the Parish Council website. Whilst also initiating the sale of the Oak Road premises, so to re-invest funds into more proactive and positive areas of our Parish.

I'm hoping to push forward, with support from fellow Councillors for the relocation of our War Memorial stone and to finally give it the prowess it truly deserves and also liaising with the Parish Councillors and Cllr James Wright to allocate a prominent position for our new ever green Christmas tree.

I have currently been restructuring the work programme of our Community Improvement workers so that we can continue to strive to become more proactive and productive in our community. Recent meetings with representatives from Trafford to form partnerships where the Parish Council can adopt more land and responsibilities in our community have taken place. In return for Trafford and Amey to work with us by maintaining large areas of our communities and increase more street cleaning machines in Partington.

I feel as Chair, I've made the Parish Council more transparent and proactive in Partington and with the support of my fellow Councillors, the Parish Council, will be the only workforce that maintains our community in the eyes of our residents.

I hope to be re-elected as Chair for another year as I am very passionate, as all members of the Parish council are about the future of Partington and its future.
